The text must be aligned on both sides (Times New Roman font, size 14). Create all non-text objects with built-in Word tools. Figures, diagrams, formulas and tables shall not go beyond the fields. Pages are not numbered. Words are not hyphenated.

# File naming requirements

- 1. Files with abstracts must have extensions \* .doc, \* .rtf.
- 2. File names must contain the name of the first co-author in **English**. For example: abstract / article Petrenko.tezi.doc, Petrenko.stat.doc.
