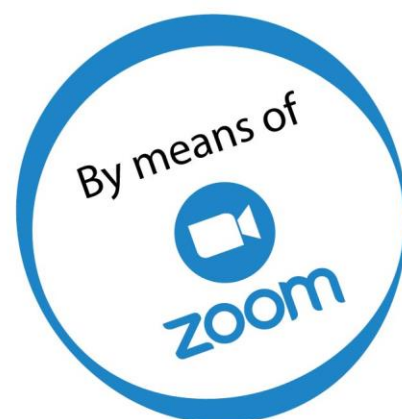

After the conference, it is planned to place a collection of abstracts in an electronic collection of scientific papers on the website of the Institute.

Formatting requirements for papers

Abstracts are submitted online while registration and are drawn up on an A4 sheet at single space. The volume of abstracts is not more than 3 pages, including figures, tables, references. The text must be aligned on both sides (Times New Roman font, size 14). Create all non-text objects with built-in Word tools. Page margins must be 25 mm. Figures, diagrams, formulas and tables must not overlap page margins. Pages are not numbered. Words are not hyphenated.

File naming requirements

1. Files with abstracts must have extensions * .doc, * .rtf.
- 2.. File names must contain the name of the first co-author in English. For example: abstract / article - Petrenko.tezi.doc, Petrenko.stat.doc.
