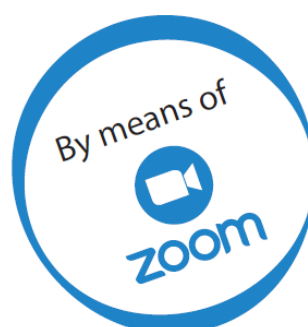

We invite you to participate in the XI International Research and Practice Conference of Young Researchers and Students "Youth Research on European Integration", held by Educational and Scientific Institute "Karazin Banking Institute" of V.N. Karazin Kharkiv National University

The plenary session of the conference will sum up the results of the second round of the All-Ukrainian competition of student research papers on the specialization "Banking".

The format of the conference is on-line (ZOOM platform).

The purpose of the conference is to discuss scientific and practical problems of economic development, effective use of modern technologies and financial instruments in order to solve the problems of European integration.

Conference focus areas:

Section 1. Language competence as a means of increasing mobility, effective international communication and intercultural interaction.

Section 2. Current issues of accounting, analysis, control and taxation of business activities.

Section 3. Strategic priorities for the development of the financial and credit system in modern conditions.

Section 4. Economics and management in conditions of global uncertainty.

Section 5. Information technologies and mathematical methods in solving modern problems of science, technology and society.

Languages of the conference: Ukrainian, English.

Terms of participation in the conference

To have the paper included in the conference program and the collection of abstracts, it is necessary to submit to the organizing committee **no later than March 28, 2022** (via the electronic registration form):

- application of the conference participant;
- abstracts and / or article (co-authored with the lecturer);
- a scanned copy of the review of a scientific advisor.

* **If there are two or more authors, the work has to be registered by only one of the authors. Necessary data of other authors will be specified in the report.**

Formatting requirements for papers

Abstracts are drawn up on an A4 sheet at single space. The volume of abstracts is not more than 3 pages, including figures, tables, references. Along with the printed-out text of abstracts, an electronic file on electronic media in .doc, .rtf formats has to be submitted. A signed review by a scientific advisor shall be scanned and submitted online.

The text should be aligned on both sides (Times New Roman font, size 14). Create all non-text objects with built-in Word tools, formulas - using the Equation editor, charts, graphs - Graph or Excel, etc. The color of graphic materials is black and white, filling is done by hatching. Margins shall make up 25 mm. Figures, diagrams, formulas and tables shall not go beyond the fields. Pages are not numbered. Words are not hyphenated.

Abstracts must have the following structure:

1. Relevance of the topic.
2. Problem statement.
3. Presentation of the main material.
4. Conclusions.
5. List of references.

After the conference, it is planned to place a collection of abstracts in an electronic collection of scientific papers on the website of the Institute [on the conference page](#)



File naming requirements

1. Files with abstracts must have extensions * .doc, * .rtf.
2. File names must contain the name of the first co-author in English. For example: abstract / article - Petrenko.tezi.doc, Petrenko.stat.doc.; review - Petrenko.rec.pdf

Abstracts have to be reviewed and recommended for publication by the supervisor. Authors and supervisors are responsible for the content of the materials. Materials must comply with spelling rules. Abstracts or articles which have not been checked for plagiarism will not be published in the Collection.

Abstracts submitted later than the deadline will not be accepted for publication. In case of failure to frame the articles in compliance with the requirements, the organizing committee reserves the right to reject the publication.
