

To make the processing as fast as possible, authors are kindly requested to conform to the following paper formatting requirements:

- ✓ Electronic documents should be in an electronic version (*.doc or *.rtf format only);
- ✓ Papers will be published in Ukrainian and English;
- ✓ Total length of the paper in A4 format should not exceed 3 pages, including all figures, tables, references, and keywords;
- ✓ All margins: 2 cm, Times New Roman (size 14), single-spaced;
- ✓ Text should be aligned on both sides without hyphenation;
- ✓ All non-text elements should be created using Word's built-in tools;
- ✓ Drawings, diagrams, formulas, and tables should not exceed the margins;
- ✓ Pages should not be numbered;
- ✓ Please conform to the following file naming convention: Lastname.paper.doc/rtf, where last name is the last name of the first author in English, e.g., Petrenko.paper.doc.

Abstracts have to be reviewed and recommended for publication by the supervisor. If the supervisor is indicated as a co-author, a review is not required. Authors and supervisors are responsible for the content of the materials. Materials must comply with spelling rules. Abstracts or articles which have not been checked for plagiarism will not be published in the Collection.

Abstracts submitted later than the deadline will not be accepted for publication. In case of failure to frame the articles in compliance with the requirements, the organizing committee reserves the right to reject the publication.

Reference list should be formatted in APA style (example);

After the conference, it is planned to place a collection of abstracts in an electronic collection of scientific papers on the website of the Institute on the conference page
