Conference Focus Areas:

Section 4. Information technologies and economic-mathematical models in the financial and credit sphere and business.

Terms of Participation in the Conference:

To have the paper included in the conference program and the collection of abstracts, please **submit the following to the Organizing Committee by May 6, 2025** via [the electronic registration form](#):

- ✓ application of the conference participant;
- ✓ abstracts and / or article (co-authored with a scientific advisor) or
- ✓ a scanned copy of the scientific advisor's review.



* *If a paper has two or more authors, it should be submitted by only one of them.*



Paper Formatting Requirements:

- submit the text file in *.doc or *.rtf format;
- papers are accepted in Ukrainian or English;
- the total length of the abstract must not exceed 3 A4 pages, including all figures, tables, and references;
- margins: 2 cm on all sides; font: Times New Roman, 14 pt; line spacing: single;
- text should be aligned to both sides and without hyphenation;
- all non-text elements should be created using Word tools;
- figures, diagrams, formulas, and tables should not extend beyond the margins;
- pages should not be numbered;
- file name: the surname of the first author in English (e.g., Petrenko.tezy.doc., Petrenko.stat.doc.)

If the author of the paper is a student of higher education, the paper must be recommended for publication by the scientific advisor and certified by their review. Authors and scientific advisors are responsible for the content of the materials. The materials must comply with the rules of spelling and orthography. Abstracts /articles that have not passed the plagiarism check will not be published in collections of papers.

Abstracts submitted after the established deadline will not be accepted for publication. The Organizing Committee reserves the right to reject materials that do not meet the requirements.
