

We invite you to participate in the IV International Research and Practice Conference "The current state, problems and prospects of business, financial and credit and accounting systems development ": Dedicated to the 80th anniversary of the founding of the Banking Institute, held by Education and Research Institute "Karazin Banking Institute" of V.N. Karazin Kharkiv National University.

The format of the conference is on-line (ZOOM platform).

The purpose of the conference is to discuss scientific and practical problems of business, financial and credit and accounting systems.

Conference focus areas:

Section 1. Modern financial institutions and instruments in an unstable global ecosystem.

Section 2. Topical issues of development and implementation of accounting, analysis, control and taxation of business activities.

Section 3. Professional management in modern organizations.

Section 4. Information technologies and economic and mathematical models in the financial and credit sphere and business.

The conference will include **Round table** on the topic: "Development of competencies of a modern banker and ways to form them in the system of higher economic education"

Languages of the conference: Ukrainian, English.

Based on the results of the conference, the following papers will be published:

- ✓ articles in the collection of scientific works (**languages: Ukrainian, English**);
- ✓ abstracts in a collection of articles (**languages: Ukrainian, English**) on electronic media (published on the website of the Institute)
- ✓ all participants will receive a certificate of participation by e-mail in PDF format.

Terms of participation in the conference

To have the paper included in the conference program and the collection of abstracts, it is necessary **to submit to the organizing committee no later than May 6, 2024** (via [the electronic registration form](#)):

- ✓ application of the conference participant;
- ✓ abstracts and / or article (co-authored with the scientific advisor) or:
- ✓ a scanned copy of the supervisor's review.

* *If there are two or more authors, the paper has to be registered by only one of the authors.*





Framing requirements for papers

- send the text document in *.doc or *.rtf format;
- papers are accepted in Ukrainian and English;
- the total volume of abstracts in A4 format shall not exceed 3 pages, including all figures, tables, and a list of references;
- all margins: 2 cm, Times New Roman (size 14), single spacing;
- the text must be aligned on both sides without hyphens;
- all non-text elements shall be created using built-in Word tools;
- drawings, diagrams, formulas and tables should not go beyond the margins;
- pages are not numbered;
- file names — the last name of the first co-author in English (for example: Petrenko.tezy.doc., Petrenko.stat.doc.)

If the author of the paper is a student of higher education, the paper must be recommended for publication by the academic supervisor and certified by his/her review. Authors and scientific supervisors are responsible for the content of the materials. The materials must comply with the rules of spelling and orthography. Abstracts /articles that have not passed the plagiarism check will not be published in collections of papers.

Abstracts sent after the established deadlines will not be accepted for publication. In the event of significant discrepancies between papers and recommendations, the organizing committee reserves the right to reject the publication.
